PAYMENT INFORMATION, REFUNDS, and REQUIREMENTS

Course tuition is payable to Trusted Armament (hereinafter known as TAC) upon application prior to training. Payment is non-refundable except as described below. All training classes stress safety first, and full time attendance is required to complete. Late arriving students will be rejected if necessary. Enrollment is on a first-come-first-serve basis depending upon applicant's eligibility, availability of slot, and receipt of tuition at TAC prior to training. Students are responsible for providing their own firearm(s), ammunition, related equipment, range fees, transportation, meals and lodging. Rental firearms are available in limited supply on a first-come first-served basis. Firearms, ammunition, and all necessary products are available for sale from Trusted Armament at a reduced price for students accepted for classes. Application must be made at minimum 7 days or more prior to class start time. In the event of student cancellation more than 15-days prior to the first day of training, a 50% refund will be made. When cancellation notice is received or class is purchased less than 15days prior to start date, fees are not refundable. Missed class hours, class days, and range times are not refundable under any circumstances unless prior arrangement are agreed upon with TAC instructor in writing. Makeup days may be available dependant upon class size in future classes for no extra charge at the discretion of TAC instructor. TAC is not responsible for any expenses, except limited tuition refund as described above, incurred by the applicant due to any form of delays, acts of God, inclement weather, or any other circumstance beyond our, or student's, control. Should a student fall behind in class a makeup time will be set aside for additional tutoring at additional expense to be determined, however, no remaining tuition will be refunded for unused portions left unfinished. In the event the host trainer and/or TAC cancel the training event prior to or during training, TAC will only be responsible to refund the unused portion of the tuition or reschedule classroom instruction at a later date, at the sole discretion of the host trainer and TAC. TAC retains the sole discretion to accept or decline all applications, and/or adjust specific class placement and/or registration as needed to insure pre-requisites are previously met. TAC instructor has, and TAC reserves, the right to remove any one at any time from class or at the range for safety reasons without explanation.

RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF THE RISK AGREEMENT

WHEREAS, in return for instruction in firearms, weapons, use of premises, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned agrees to the following:

The Undersigned agrees to indemnify, hold harmless and defend Trusted Investigations and Protection Services, L.L.C. d.b.a. Trusted Armament Corp. (hereinafter "TAC", and any of its employees, directors, officers or agents), from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with: the discharge of firearms; the course of instruction; the Undersigned 's participation in the course of instruction; the range, buildings, land and premises used for the course of instruction (hereinafter the "Premises"); the Undersigned's presence on or use of said Premises; and any and all acts or omissions of the Undersigned. Should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, the Undersigned will indemnify, hold harmless and defend the TAC, from any and all costs, expenses or liability including, but not limited to, the cost of any settlement or judgment made or rendered against the TAC, whether individually, jointly, or in so lido with the Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand or lawsuit, including attorney's fees.

The Undersigned furthermore waives for himself/herself and his/her executors, administrators, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever, which he/she may have or which may arise against TAC, (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which may, in any way whatsoever, arise out of, be related to or be connected with: the course of instruction; the Premises, including any latent defect in the Premises; the Undersigned's presence on or use of said Premises; the Undersigned's property (whether or not entrusted to the TAC); and, the discharge of firearms. The TAC shall not be liable for, and the Undersigned, on behalf of himself/herself and his/her executors, administrators, assignees or heirs, hereby expressly releases the TAC from any and all such claims.

The Undersigned hereby expressly assumes the risk of entering the Premises and of taking part in activities on the Premises, which include, but are not limited to, instruction in the use of firearms, the discharge of firearms and the firing of live ammunition.

The Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands and will at all times abide by all TAC range rules and procedures. This instrument binds the Undersigned and his/her executors, administrators, assignees or heirs
